Call to Order

- Shuttle Update: Shelby reported no new updates on the shuttle service, as the involved family is focusing on their ice cream shop business.
- Solvang Festival Theater: Linda complimented the comedy show held the previous night and commended the volunteers for their efforts in bringing talent to the Santa Ynez Valley.

Board Comments

Jonathan shared First & Oak is catering many events, making positive memories for guests. Jeff shared High Line Adventures had a strong August, though September has slowed with students returning to school. He anticipates strong international travel and looks forward to the holiday season, including Halloween zipline adventures. Stormie shared Chumash hosted 90 rooms for secret service agents during the President's visit. September and October are strong with corporate bookings, weddings, and weekend visitors. Greer noted business is slower in September but gearing up for the holidays at Fess Parker. She shared excitement for the winery's new Napa tasting room introducing people to Santa Barbara County wines. Kathleen shared they had the highest revenue months in Alisal's history this summer and are now focusing on group business. Kristopher shared weekend bookings are strong at The Genevieve, but midweek is a challenge. He is preparing for the fall menu at The Victor and building 2025 budgets. Jim shared August was the best on record at Hampton Inn & Suites, driven by Biden's visit and SpaceX launches. Launch related business continues to fill rooms into Q1. Cynthia is working on site visits at all SYV hotels and is assisting with the lacrosse group event in 2025. She is currently preparing for 45 one on one meetings with operators from the UK and across Europe during the Brand USA mission. Shelby is excited and grateful for the upcoming Taste of the Santa Ynez Valley event. Danielle thanked the staff and partners for their hard work on the Taste event and is working with Griffin Publishing on the 2025 Destination Guide. Linda provided insights into international hospitality trends and emphasized the importance of supporting local events like Danish Days. She thanked the board and staff for their efforts and congratulated everyone on a successful meeting.
